1990 SAR Incident Summary

Vol. 4, 1991

The 1990 SAR statistics are now out, and following are some of the highlights of the report:

* In 1990, SAR authorities recorded a total of 7,200 SAR incidents which represents a slight rise of 0.5% over 1989. However, over the past three years, there has been a 6.4% decrease in the total number of SAR incidents.

* Have the potential to deteriorate into distress incidents if not responded to in a timely and effective manner.

- * A total of 2,314 lives were considered at risk as a direct result of SAR distress incidents in 1990. Of these, 2,100 (90.8%) were saved, and 214 (9.2%) lost.
- * Types of craft assisted:



* Leading Causes of Distress Incidents:


1. Medical	182 cases
2. Capsized	132
3. Taking on water	116
4. Fire	65
Man Overboard	45

- * In 1990, the CMRA responded to 20% of total SAR incidents, and 37% of SAR incidents responded to by non primary CCG SAR resources.
- * CMRA units were called upon 1,926 times in 1990, an 8% increase over 1989 when 1,787 units were utilized.

As the statistics above demonstrate, the Auxiliary plays a key operational role in the National SAR Program.

Insurance Bits

- * To be covered by the CMRA insurance policy, you must be on an authorized activity, and in the case of SAR operations, have an incident tasking number assigned by a Rescue Coordination Centre.
- * Coverage under the CMRA insurance policy is also dependent on your vessel passing an examination. If you are new to the CMRA, make sure your vessel is inspected before accepting call outs.
- * The CMRA insurance policy provides the following coverage for total loss of vessel while on authorized activities:
 - > Up to \$ 2,000,000 for commercial fishing vessels.
 - > Up to \$ 1,650,000 for commercial vessels.
 - > Up to \$ 500,000 for any other vessel (eg: Pleasure Craft).

Rescue Coordination Centre Tasking Numbers

All CMRA members are reminded that in order to make a re-imbursement claim for SAR operations, you must quote the tasking number for the incident.

These numbers are issued by the Rescue Coordination Centres when CMRA resources are called upon to provide assistance. Even if you are already at sea and become aware of an incident in your area, make sure that you contact the Rescue Coordination Centre if it appears you should respond.

New Shore Protection Legislation

In August of 1991, the Ship Safety Branch of the Coast Guard made an important addition to the Boating Restriction Regulations. The new regulation imposes a 10 km/h speed limit for all vessels operating within 30 metres from shore.

The new regulation should enhance the safety of persons swimming or participating in recreational pursuits within this area. The speed restriction should also slow the effects of shoreline erosion.

Provinces are free to adopt the legislation if they wish to do so, and so far, Saskatchewan, Manitoba and Ontario have adopted the legislation. Other provinces are expected to follow suit shortly.

New Members of Coast Guard Family




On June 7, 1991, in Bella Bella B.C., the first of the Coast Guard's two new primary SAR vessels, the 'Gordon Reid' was christened. Gordon Reid was the first native indian in B.C. to obtain his Ship Master's Certificate, and was renowned as one of the best navigators on the west coast.

The CCG Gordon Reid is 50 metres in length, 11 metres wide, and has a draught of 4 metres. Power comes from four six cylinder engines which provide a top speed of 16 knots. The vessel, with six officers and eight crew, has a range of 2,500 nautical miles and can remain at sea for a month at a time.

Other noteworthy features include a stern launch ramp allowing a fast rescue craft to be launched in severe weather and a 400 HP bow thruster for added manoeuvrability.

The Gordon Reid, based in Victoria, will no doubt enhance the Coast Guard's response capability on the west Coast, as will her sister ship, the 'Jacobsen' which went into service in September.

The "Gordon Reid" and "Jacobsen" replace the last two 29 metre "R" Class SAR cutters, which had got very old and tired.



PARU Celebrates 25th Anniversary

The Canadian Coast Guard would like to congratulate Pickering Auxiliary Rescue Unit (PARU) on the occasion of their 25th anniversary.

PARU was founded in 1966 to relieve local police from the demanding task of rescuing people on Lake Ontario. With financial support from the town of Pickering, a rescue craft was purchased and has been manned since then by a dedicated volunteer membership.

In 1979, PARU became one of the first units to join the newly formed CMRA. Today, they play a key role in SAR operations in the area, responding to more than 1,200 vessels in distress since their inception in 1966. PARU is also active in prevention with members assisting the Coast Guard in safety demonstrations and courtesy examinations.

The Coast Guard looks forward to it's continued association with PARU.
